

What are FSIs?


FSIs are aggregate indicators of the current health of a country's financial sector (deposit takers and other financial subsectors) and its counterparts (corporates, households, real estate markets).

- Inspired by financial regulatory practices and CAMELS
 - Capital adequacy
 - Asset quality
 - Management
 - Earnings
 - Liquidity
 - Sensitivity to market risk



- Sectoring of institutional units
- Financial instrument classification




New FSI report forms

Number of FSIs Reporting Countries




